Shipped semen is based on availability.

Stallions will not be collected on a non breeding day.

BREEDING CONTRACT

I hereby agree on the _____ day of _____ in the year _____ to breed the mare, _____, Reg. No. _____, to the Stallion, NO FINER SHINER, for the 20____ season. The Breeding fee is \$ _____, which includes a NON-REFUNDABLE Booking Fee of \$ _____. The balance of the Breeding Fee must be paid at least 10 days prior to the shipment of the semen.

The above applies to the normal breeding season, February 1 through July 15 of each year.

This contract contains a "Live Foal Guarantee". A live foal is described as a new born foal which stands and nurses without assistance. Should a live foal not be produced from this breeding a rebreed will be honored the following year with a rebreed fee of _____. Rebreed privileges shall apply only if NO FINER PARTNERS is notified within seven (7) days thereof, and receives a veterinarian's statement confirming death. The rebreed shall apply only to the next normal breeding season unless other agreements are negotiated. A substitute mare may be sent if the original mare is deemed unfit for breeding, at the discretion of NO FINER PARTNERS.

The "Live Foal Guarantee" in this contract is non-transferrable.

The "Breeders Certificate" will be issued only after all breeding and veterinary expenses have been paid in full and after the foal is born and has been reported to NO FINER PARTNERS.

If an embryo transfer, from a single flush, results in multiple pregnancies, the mare owner will be required to sign an additional contract and another Breeding Fee will be due prior to issuing a breeders certificate for the resulting foals.

I understand and agree that No Finer Partners nor its representatives will be responsible for injury, sickness, or death to the mare or foal. The Mare Owner agrees to and shall indemnify and hold harmless NO FINER PARTNERS and its principals and its staff from and against any and all claims, losses, damages, causes of action, suits, liability of every kind, for injury or death of the mare or its foal, arising out of or in connection with the services performed by NO FINER PARTNERS and its staff and associates under this contract.

The parties further agree that should the Stallion die or become unfit for breeding purposes, this contract shall become null and void and any money paid on the Breeding Fee, except for the non-refundable booking fee, shall be refunded to the Mare Owner.

When signed by both parties, this document will become a legally enforceable contract, binding upon both parties. The parties acknowledge that this agreement shall be entirely governed by, construed and enforced under the laws of the Province of Ontario, Canada.

In the event that there is any dispute, all disputes of every kind between the parties to this agreement shall only be submitted to arbitration and any award made by the arbitrators shall be considered final and binding.
